Rules for School Bus/Transport

- 1. Buses will run at their prescribed route as per route chart.
- 2. Bus Stoppage decided by school will be constant throughout the current academic session.
- 3. No request regarding creation of new stoppage will be entertained during this period.
- 4. Parents are requested to inform with application to the School Authority one week before in case there is change in address.
- 5. Students will be duly informed verbally for any change in time regarding school transport during special programmes of the school or any other emergency.
- 6. School will not be responsible if buses will be late because of any unavoidable circumstances like road jam and blockade.
- 7. At the time of BANDH called by organization, operation of buses will automatically be stopped for the safety and security of students.
- 8. Students are advised to reach their proper stoppage 5 minutes before the arrival of buses; otherwise school will not be responsible for missing bus on the allotted route.
- 9. Students are advised to take their seats in the buses of their prescribed route. They are not permitted to enter in any other bus which moves over that route.
- 10. Parents are advised to reach their ward's stoppage 5 minutes before to receive them. School will in any case not be responsible for any untoward incident afterward.
- 11. School will not take any responsibility to any injury in the bus due to mechanical trouble however first aid should be given on humanitarian ground for only minor injury.
- 12. Parents whose ward avail bus facility will not be permitted to take their ward from buses on route before their prescribed stoppage or without prior permission of the Principal.
- 13. Parents whose wards are availing bus facility are requested to lodge any complaint or suggestion regarding school transport at school office "No complain on the matter will be accepted on the way".
- 14. School is having right to change the bus stop and route if asked by Parents / Guardians for their wards.
- 15. Transport charges are to be paid for only eleven months in one academic year. No request to discontinue. Bus facility will be entertained during the academic year.
- 15. In extra ordinary circumstances (fuel cost hike) parents will have to bear the midterm transport fee hike by the school.
