Core Language : English Core, Hindi Core

Elective Subjects: English Elective, Hindi Elective, Physics, Chemistry, Maths, Physical Education, Biology, Economics, Business Studies, Geography, Political Science, History and Accountancy.

The sanction is subject to the fulfillment of the following conditions in addition to the general conditions intimated at the time of grant of Regular affiliation for secondary classes:-

1. The school will provide additional suitable facilities for classes XI and XII, as per requirements.
2. It will increase the number of books in the Library and equipments in the Laboratories/Workshops with adequate games facilities etc. in consonance with the requirements of the Board for Classes XI & XII.
3. The school must follow Uniform System of Assessment, Examination and Report Card for classes VI-IX from Academic Year 2017-18 onwards as per the Board's Circular No:Acad-14/2017, dated 21.03.2017.
4. The school must submit it's information through Online Affiliated School Information System (OASIS) as per the Board's Circular No:CBSE/Aff./4/Circular/2016, dated 10.11.2016, within 30 days from the receipt of this grant letter. Link for OASIS is available on Board's website:www.cbse.nic.in.
5. It will appoint only qualified staff to teach Classes XI & XII as per requirements laid down by the Board.
6. It will provide for adequate co-curricular and extra-curricular activities for the wholesome development of the students.
7. It will abide itself by the Affiliation Bye Laws of the Board and other rules and regulations prescribed by the Board from time to time.
8. It will continue to pay Annual Fee of Rs.3000/- per annum. The schools run by Govt./Govt. Aided are granted regular affiliation and these schools have been advised to remit prescribed annual fee in CBSE by D.D./Cash in favour of Secretary, CBSE, payable at CBSE, H.Q., Preet Vihar, Delhi-110092.
9. Annual fee has been received upto 31/03/2018.

11. Special condition to be completed within 03 months.
